As a Deportation Officer, Mr. West is responsible for upholding U.S. immigration law at, within, and external to our Nation's borders. He enforces immigration law against those who present a danger to U.S. national security, are a threat to public safety, or who otherwise undermine the integrity of America's immigration system. Mr. West performs the following:

- Serve as Acting Supervisory Deportation and Detention Officer periodically, to include during a detail assignment to the Alternatives to Detention Unit in Laredo, Texas. Plan and direct subordinate work assignments, establish performance goals, evaluate work assignments, approve/disapprove leave request, coach/mentor and administer disciplinary actions as necessary.
- Assisting Alternatives to Detention Unit with case management and compliance issues; performing regular and recurring case reviews to make determinations on non-citizen compliance based upon adherence to individual requirement of the non-citizen.
- Advise and direct fellow deportation officers and other LE officials in performance of their duties which includes intelligence gathering/assessing, identifying, arresting, detaining, and removing aliens.
- Search various data bases, review and analyze information relevant to violations of immigration law; leverage other authorized sources such as the public, aliens, LE partners, surveillance and other technologies to identify, locate and arrest those violating the Immigration and Nationality Act, as amended, and related regulations and/or policies. Determine identity, alienage, removability, and case statuses of criminal violators. Launch investigations, plan and develop cases for prosecution or administrative action.
- Obtain and execute criminal search and/or arrest warrants; interrogate suspects; take sworn statements; determine appropriate removal process; prepare charging documents, warrants and other arrest documentation; gather intelligence; initiate proceedings against immigration violators; notify consular as appropriate and record activities in relevant databases, systems, and written reports.
- Analyze intelligence reports and data of substantial importance to ICE, other LE agencies, and the intelligence community. Evaluate and validate reliability of intelligence related to criminal and gang activities and determine applicability to designated operations.
- Render advice related to developing, implementing, and evaluating the ICE Law Enforcement Support Center's processes and procedures to improve operational effectiveness.
- Develop relationships, networks and alliances with ICE internal and/external partners including Federal, state, local, tribal, and foreign-governmental LE officials and entities, consular officials, contractors and other stakeholders conducting or supporting detention and deportation law enforcement activities.
- Serve as lead Enforcement and Removal Operations LE official on joint task force operations comprised of Federal, state, local and other LE partners, carrying out national and local LE initiatives.

- Execute custody determinations by applying knowledge of and skill in administering complex investigative methods and techniques to support criminal and/or civil prosecutions; apply comprehensive knowledge of the principles, methods, and processes used to conduct systematic and objective inquiries, including collection, analysis, interpretation of data, and reporting results; independently determine and initiate proper management actions; conduct legal sufficiency reviews based on research and knowledge of applicable governance, mitigating potential legal liabilities; conduct Post Order Custody Reviews and custody determinations; decide custody conditions; ensure compliance with agency standards for safekeeping and humane treatment of aliens in ICE custody; prepare documents for case adjudications and respond to applications/requests for benefits, relief, release, etc., including bonds, parole, voluntary departure, stays or deportation or removal and deferred actions.
- Notify supervisor of cases that require special attention, e.g., human rights violators, etc.
- Coordinate, manage and execute non-citizen deportations, to include obtaining travel documentation and relying upon relationships with other Federal, state, local and foreign government officials, airport and airline representatives; escort aliens as required.
- Apply strategies and tactics to manage the immigration enforcement process, including the identification and arrest, transportation, detention, case management, and removal of undocumented individuals.
